

OutThink - Rules & Regulations

- By entering the Competition, the Teams agree to comply with and shall be bound by the terms and conditions of the Competition. Failure to comply with these rules and/ or any terms and conditions may result in Team's disqualification from the Competition. L&T reserves the right in its sole discretion to disqualify any Team it finds to be:

 - Acting in an unsportsmanlike or disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; or
 - o Fails to provide documentation verifying eligibility.

- L&T reserves the right, at any stage, to disqualify any team without notice to the Team, including but not limited to, if it believes in its sole and unfettered discretion that such Team violates any law or regulation for the time being in force, infringes upon any third party right or otherwise does not comply with these terms and conditions. L&T's decision in this respect will be final and binding on the participants.
